

**REGULAR MEETING
MAY 2, 2023**

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Strayer, Batt and Sangialosi, Solicitor Matthew McKnight, Planning Committee Chairman, Andre Weltman, Emergency coordinator, Robert Kough, Roadmaster Doug Kutz, resident, Becky Moorehead and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the April 4, 2023 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of April 30, 2023, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for May 2, 2023, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the April 4, 2023 meeting, second by Supervisor Batt. Vote unanimous.

The road crew blew leaves from township ditches on several roads. Put 15-ton 2A's on Ice house. Went to Motters and Zimmermans concerning new truck bed and sandblasting for F550. Picked up 25MPH signs for High Mountain Road and installed. Met with Jerry Schlusser concerning paving project. Went for new truck bed. Put 10-ton 1B's on Marie Dr. Prepared Bendersville road for paving and assisted with paving and flagging. Went to inspect a grader for purchase. Cleaned vehicles.

Planning Committee Chairman, Andre Weltman reported that he didn't have any update from the county concerning street addresses.

Supervisor Sangialosi gave an update from the WCCOG meeting.

Supervisor Sangialosi motioned to purchase dump truck fenders for F550. Seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to bid on a grader up to \$20,000.00, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to replace Penn townships' cones that were taken while they were being used on our township road, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned for Solicitor McKnight to advertise the Flood Plain Ordinance 2023-01, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to ratify the paving of the sides and pipes on Bendersville Rd., seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to purchase two road closed signs for Emergency Coordinator, Robert Kough, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to adjourn the meeting, second by Supervisor Batt. The meeting adjourned at 8:23pm.
