

**REGULAR MEETING  
MAY 3, 2022**

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Batt, Sangialosi, and Strayer, Solicitor Matthew McKnight, Planning Committee Chairman Andre Weltman, Emergency coordinator Robert Kough, residents, Becky Moorehead and Robert Minck and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the April 5, 2022 meeting, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of April 30, 2022, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for May 3, 2022, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the April 5, 2022 meeting, second by Supervisor Batt. Vote unanimous.

Road crew checked roads. Cut up tree on Bendersville Rd. and pick up limbs on various roads. Spread stone on dirt roads and blew off anti-skid from the remaining roads. Drug Ridge Road. Replaced Leaf Rd. sign that was stolen.

Planning Chairman, Andre Weltman, reported that we are awaiting a response from Kirk Stoner regarding Quarry Bridge funding.

Supervisor Sangialosi motioned to have Emergency Coordinator, Robert Kough send a complaint letter to PUC regarding the slow response time from Met Ed when a fire is in progress, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to adopt Resolution 2022-04 in response to the Zito Media contract, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to waive the valuation permit fee for the upgrade to the tower at Pine Grove State Park, seconded by Supervisor Batt. Vote unanimous.

The Supervisors went to executive session at 7:55pm and resumed the meeting at 8:13 pm. No decisions were made.

Supervisor Sangialosi motioned to review the tax collector fees at the next budget meeting, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to contact Bill Cornman in regards to continuing employment, seconded by Supervisor Batt. Vote unanimous.

Andre Weltman reminded the Supervisors that the Iron Run half marathon and 5K run will be June 11, 2022.

Supervisor Sangialosi motioned to adjourn the meeting. Second by Supervisor Batt. The meeting adjourned at 8:15 P.M.
