

**REGULAR MEETING  
SEPTEMBER 6, 2022**

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Batt, Sangialosi, and Strayer, Solicitor Marcus McKnight, Planning Committee Chairman Andre Weltman, Engineer Paul Wilson, residents, Becky Moorehead, Steven Day, and Barry Smith and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the August 2, 2022 meeting, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of August 31, 2022, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for September 6, 2022, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the August 2, 2022 meeting, second by Supervisor Batt. Vote unanimous.

Roadmaster Kutz did maintenance on trucks. Took F550 and pickup for inspection. Paved shoulders of Oak and Dogwood cul-de-sacs. Paved a portion of Bendersville Road shoulders and an area in the middle of the road. Worked at Penn Township 8 days. Dragged roads. Put up 25mph signs on Old Shippensburg Road. Filled potholes.

Secretary Frantz reported that in lieu of taxes funds were received. Southampton Township is increasing the late fee to 10% of the balance due for trash bills.

Supervisor Sangialosi motioned for the use of fire police for the Ironmasters Run, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to contract with Heller's Gas for propane until June 1, 2023, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to contact a scanning company for township oldest records, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi reported that there is no August COG meeting.

Supervisor Sangialosi motioned for Solicitor McKnight to send a letter to 14 Pinebrook concerning a barking dog, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi gave an update on the Quarry Bridge funding.

Supervisor Sangialosi motioned for Paul Wilson, township engineer to assist resident, Steven Day with his water run off issues. Mr. Day is to pay all fees. Seconded by Supervisor Batt. Vote unanimous.

Supervisors tabled the township water treatment until next meeting.

**Resident, Barry Smith reported that Bendersville Road as several areas that his car bottoms out where the road as sunk at drainage pipes. Supervisor Sangialosi responded that Bendersville Road is scheduled for 2023 road project.**
