

**REGULAR MEETING
December 3, 2024**

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Sangialosi and Batt, Solicitor Matt McKnight, Planning Committee Chairman, Andre Weltman, Robert Kough, Jr., Emergency Coordinator, resident, Becky Moorehead, and Secretary Frantz. Supervisor Strayer unavailable due to a family commitment.

Supervisor Sangialosi motioned to approve the minutes of the November 4, 2024 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of November 30, 2024, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for December 3, 2024, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the November 4, 2024 meeting, second by Supervisor Batt. Vote unanimous.

Roadmaster took the F450 for inspection and picked up. Installed new Cold Springs Rd. sign. Got the pad ready for the pole building. Assisted as needed with the pole building. Picked up 2x8 boards for around the bottom of the building. Filled in floor area of pole building with shale and leveled. Blew leaves from ditches and drain pipes. Took down the burn ban signs. Placed 2A's on Ridge Rd. and Cold Springs Rd. Fixed holes on Ridge, Peach Orchard and Leeper Farm. Went for snow plow parts.

Secretary Frantz reported that a new fire extinguisher was purchased for the new pole building. An application for employment was received.

Supervisor Sangialosi reported on the COG meeting. Kelly Neiderer reported that the 2025 County budget was advertised and available for review. The 2025 COG budget was passed with 1/2 dues to members. New officers were elected.

Supervisor Sangialosi motioned to ratify the removal of a burn ban for the township, seconded Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to have Solicitor McKnight advertise the fire safety ordinance with minor changes, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to have Solicitor McKnight advertise the supervisor's salary ordinance, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to adopt the 2025 budget and tax rate, seconded by Supervisor Batt. Vote unanimous.

Supervisor Batt motioned to accept the comcast franchise agreement, seconded by Supervisor Sangialosi. Vote unanimous.

Supervisor Sangialosi motioned to sign the letter permitting South Penn Enduro Riders to have a race September 07, 2025, seconded by Supervisor Batt. Vote unanimous.

Resident Becky Moorehead read a portion of the Constitution.

Supervisor Sangialosi motioned to adjourn the meeting, seconded by Supervisor Batt. The meeting adjourned at 8:00pm.
