

**REGULAR MEETING
JUNE 6, 2023**

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Strayer, Batt and Sangialosi, Solicitor Matthew McKnight, Planning Committee Chairman, Andre Weltman, Emergency coordinator, Robert Kough, residents, Becky Moorehead, Kevin Blessing, and Robert Minck, and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the May 2, 2023 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of May 31, 2023, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for June 6, 2023, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the May 2, 2023 meeting, second by Supervisor Batt. Vote unanimous.

Resident Kevin Blessing inquired about the complaint letter he received from the township. Supervisors discussed the complaint and the ordinance that was being violated.

Roadmaster Kutz went to Bart Township to look at a grader advertised on Municibid with Harvey Reiff. Bid on grader per Supervisor's approval. Went to Bart Township to pick up grader after winning bid. Reinstalled stop sign at Rt. 233 and Ridge Rd. Black Swamp Road sign taken again. Dragged dirt roads. Trimmed around township building. Cleaned front windows in office. Graded Ridge and Peach Orchard roads. Put beacon light on grader. Replaced stop sign at Quarry Rd. and painted sign post. Put mower on and mowed Quarry, Bendersville Rd. and extension, by the campground and Old Shippensburg Road. Sandblasting and painting done on F550 and taken to install new truck bed. Turned the flails on the mower and mowed Icehouse and Iron Run. Cleaned up tree on Cold Springs Road.

Supervisors gave permission to place a large rock at the end of Black Swamp Rd. with Supervisor Batt painting the road name on it.

Planning Committee Chairman, Andre Weltman has scheduled meeting for the Old Shippensburg Road addresses with Forestry.

Supervisor Sangialosi gave an update from the WCCOG meeting.

Supervisor Sangialosi motioned to give Secretary Frantz permission to transfer the grader title, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to institute a fire burn ban in the Township, seconded by Supervisor Batt. Vote unanimous.

Emergency coordinator, Robert Kough gave an update on the P25 radios, worker's compensation meeting at Penn Fire Hall, and EAP for June race.

Supervisor Sangialosi motioned to adjourn the meeting, second by Supervisor Batt. The meeting adjourned at 8:19pm.
