Supervisor Sangialosi called the meeting to order and led the group in the pledge to the Flag.

Supervisor Sangialosi appointed Supervisor Batt as the Temporary Chairman, second by Supervisor Batt.

Supervisor Sangialosi appointed Janet E. Frantz as Temporary Secretary-Treasurer, second by Supervisor Batt.

Supervisor Batt motioned to appoint Supervisor Sangialosi as Chairman, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to appoint Supervisor Batt as Vice Chairman, second by Supervisor Batt. Vote unanimous.

Supervisor Batt made a motion to appoint Janet E. Frantz as Secretary-Treasurer, second by Supervisor Sangialosi. Vote unanimous.

Supervisor Batt made a motion to adopt, approve and sign Resolution 2025-01, Appointments and Establish Monetary Rates for 2025, second by Supervisor Sangialosi. Vote unanimous.

Supervisor Batt made a motion to adjourn the meeting, second by Supervisor Sangialosi. The meeting adjourned at 7:35 PM.

**REGULAR MEETING  
JANUARY 6, 2025**

The regular monthly meeting of the Cooke Township Supervisors was held following the reorganization at the Township Building, 1700 Centerville Road, Newville, PA. Supervisor Sangialosi motioned to approve the minutes of the December 3, 2024 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of December 31, 2024, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for January 6, 2025, second by Supervisor Batt. Vote unanimous.

**Supervisor Sangialosi motioned to approve the ratification of checks written after the December 3, 2024 meeting, second by Supervisor Batt. Vote unanimous.**

**Secretary Frantz reported that the road sign for Michaux Rd. was stolen at the intersection with Ridge Rd. In the spring a rock will be placed and Michaux Rd. will be painted on it. The Township received a letter from SEO Vince Elbel stating that he is retiring on December 31, 2025.**

**Jennifer Henry, race director for Buck Ridge Burn Trail Races, gave notification that the race will be held on April 6, 2025 from 6am to 2pm. The State required her to provide proof of this notification. A full Emergency Action Plan is in place.**

**Supervisor Batt motioned to return the bond for Douglas Miller Construction, seconded by Supervisor Sangialosi. Vote unanimous. The Township pole building is completed.**

**Planning Committee Chairman, Andre Weltman is continuing to reach out to cabin owners concerning the posting of address numbers.**

**Supervisor Sangialosi gave update from the WCCOG meeting that John Mizerak from Brightspeed attended the meeting stating that the company will bid for funds for underserved internet areas. Cumberland County Commissioner, Jean Foschi mentioned that 2025 dog licenses are now on sale. She also stated that the Cumberland County Library system requested a tax millage increase.**

**Supervisor Sangialosi motioned to adjourn the meeting, second by Supervisor Batt. The meeting adjourned at 8:18 P.M.**
