

**REGULAR MEETING
SEPTEMBER 5, 2023**

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Strayer, Batt and Sangialosi, Solicitor Matthew McKnight, Planning Committee Chairman, Andre Weltman, Emergency coordinator, Robert Kough Jr., resident, Becky Moorehead, and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the August 1, 2023 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of August 31, 2023, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for September 5, 2023, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the August 1, 2023 meeting, second by Supervisor Batt. Vote unanimous.

Roadmaster Kutz took the F550 and the pickup for inspection at D & J's. Dragged Leeper, Iron Run and Icehouse. Fixed holes on Icehouse, Cold Springs, Old RR Bed, Leeper and Murphy roads. Fixed washouts on Ridge and High Mountain roads. Trimmed trees. Clean drain on Ridge Road. Mowed at the township building. Installed markers on Iron Run. Cut up tree on Old RR bed road. Fixed pipe on Bunkerhill Rd. Purchased a new battery for the F550. Put 2A's on Peach Orchard, Ridge and Bunkerhill roads. Put mower on the tractor and continued to mow sides of various roads.

Secretary Frantz requested to purchase 2-3-ton blacktop to patch a dip on Michaux Rd. The Township received a letter from Comcast stating that if funding was available, they would ask for a contract to enter township. Inquiry was made concerning a building permit for a YURT on private property. An anonymous complaint was made about a dog barking in Pinebrook. Forest reserve monies were received in the amount of \$20,849.64.

Supervisor Sangialosi motioned to authorize Robert Kough Jr to order a sign for no trucks Road closed ahead, seconded by Supervisor Batt. Vote unanimous.

Emergency coordinator, Robert Kough Jr. reported on the Ironmasters Challenge.

Supervisor Sangialosi motioned to adjourn the meeting, second by Supervisor Batt. The meeting adjourned at 8pm.
