

**REGULAR MEETING
December 3, 2019**

The regular monthly meeting of the Cooke Township Supervisors' was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting was Supervisors' Sangialosi, Strayer, and Batt, Planning Committee Chairman, Andre Weltman, Solicitor Matthew McKnight, and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the November 4, 2019 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as November 30, 2019, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for December 3, 2019, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the November 4, 2019 meeting, second by Supervisor Batt. Vote unanimous.

Road crew checked all roads and removed limbs during the month. Put salt spreader on GMC. Dragged Leeper Farm road. Hauled 19-ton 2a's on Ridge and millings. Dragged High Mountain and Ridge. Put pipe in on Leaf Rd and 233. Fire Extinguishers serviced and put back into vehicles and shop. Took GMC to get inspected and picked up. Replaced hydraulic hoses on spreader. Assisted with tree removal at township building and cleaned up brush and wood. Put 3-ton 2A's in where the trees were cut down to increase parking at the township building. Hauled stone on Ridge (5.5-ton 2A's) and Cold Springs (20-ton 2A's). Made post markers for Pine Tree Drive and made new head marker for Peach Orchard. Replaced garbage tote at 142 Pine Tree Drive. Sealed cracks on Bendersville, Michaux Oaks, and Ridge roads. Checked roads after snow fall and plowed Bendersville, Ridge and Michaux Roads. Put plow frame and salt spreader on 550 Dump truck. Chevy pickup spreader to Motters for repair. GMC hydraulic motor repaired. Sealed cracks in township parking lot. Picked up salt spreader and prepped trucks for impending bad weather.

Planning Committee Chairman Andre Weltman reviewed the solicitation ordinance with the Supervisors.

Supervisor Sangialosi stated that the COG voted no increase in dues. Wilbur Wolf was inducted into the Big Spring Hall of Fame. Passed a resolution to support fire and EMS pending legislation.

Supervisor Strayer motioned to adopt the 2020 township and state budgets, second Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the meeting dates for 2020, second by Supervisor Batt. Vote unanimous.

Supervisor Batt motioned to approve DD Mersch Hauling to haul stone as needed for the township, second by Supervisor Strayer. Vote unanimous.

Supervisor Strayer motioned to adjourn the meeting, second by Supervisor Batt. The meeting adjourned at 8:07 P.M.
