

**REGULAR MEETING  
OCTOBER 4, 2022**

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Batt, Sangialosi, and Strayer, Solicitor Matt McKnight, Planning Committee Chairman Andre Weltman, residents, Becky Moorehead, Linda and Barry Smith and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the September 6, 2022 meeting, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of September 30, 2022, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for October 4, 2022, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the September 6, 2022 meeting, second by Supervisor Batt. Vote unanimous.

Roadmaster Kutz took the chain saw for maintenance after cutting tree up on Old RR Bed Rd. Drug Peach Orchard, Leeper Farm, Cold Springs, Ice House, Iron Run, Quarry, and High Mountain roads. Spread stones on Ridge Road. Patched holes on High Mountain, Michaux, Quarry, and Cold Springs. Picked up chain saw and cut up tree on Murphy Road. Change oil in pickup. Picked up 7-ton #4 stone for stockpile. Took hoses off mower and purchased new hoses. Ordered salt and mixed with anti-skid upon delivery.

Secretary Frantz reported that the budget meeting is scheduled for October 20 at 1pm.

Supervisor Sangialosi motioned to purchase a new chain saw, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to contract with Negley's Water for the installation of a water treatment system, seconded by Supervisor Batt. Vote unanimous.

Supervisor Batt motioned to hire David Sangialosi to road crew, seconded by Supervisor Strayer. Supervisor Sangialosi abstained.

Supervisor Sangialosi gave an update on the Quarry Bridge.

Supervisor Sangialosi motioned to pay the Township's share of Friendship hose #1 EMS workers compensation, seconded by Supervisor Batt. Vote unanimous.

Andre Weltman reported on the Fall Furnace Fest at the Park, spotted lantern fly, and gypsy moth.

Supervisor Sangialosi report that the WCCOG signed a two-year contract with MDIA for UCC permits. The Cumberland County web address has changed to [cumberlandcountypa.gov](http://cumberlandcountypa.gov) from [ccpa.net](http://ccpa.net).

**Solicitor McKnight sent a letter to a resident concerning a dog complaint in Pinebrook.**

**Cooke Township polling place has returned back to the township building after ADA ramp installed.**

**The Supervisors discussed the Zito contract renewal with no decisions made at this time.**

**Supervisor Sangialosi motioned to pay the Township's share of Friendship Hose #1 EMS workers compensation, seconded by Supervisor Batt.**

**The Supervisors discussed paving 1.1 miles of Bendersville Rd for the 2023 road project.**

**Supervisor Sangialosi motioned to adjourn the meeting. Second by Supervisor Strayer. The meeting adjourned at 8:35 P.M.**
