

**REGULAR MEETING**  
**November 3, 2025**

**The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Sangialosi, Batt, and Schmidt, Solicitor Marcus McKnight, Emergency Coordinator, Robert Kough, Planning Committee Chairman, Andre Weltman, resident, Becky Moorehead, and Secretary Frantz.**

**Supervisor Sangialosi motioned to approve the minutes of the October 6, 2025 meeting, second by Supervisor Batt. Vote unanimous.**

**Supervisor Sangialosi motioned to approve the Treasurer's report as of October 31, 2025, second by Supervisor Batt. Vote unanimous.**

**Supervisor Sangialosi motioned to approve the checks list for November 3, 2025, second by Supervisor Batt. Vote unanimous.**

**Supervisor Sangialosi motioned to approve the ratification of checks written after the October 6, 2025 meeting, second by Supervisor Batt. Vote unanimous.**

**Secretary Frantz read the roadmaster's report.**

**Secretary Frantz took the computer to be upgraded to Windows 11. The processor was too old for the free version. The computer will be okay for 2 years but may need to be replaced at that time.**

**Secretary Frantz scheduled a meeting for November 17<sup>th</sup> with Brooke Weary from the Conservation District to review Leeper Farm Rd. and Quarry Rd. washout.**

**Supervisors discussed the erosion on Quarry Road.**

**Supervisor Sangialosi reported on the COG meeting. Trash bids are due in December at Southampton. The County gave an update on the facility master plan and asked for comments.**

**Supervisor Sangialosi motioned to accept the COG bid for Eastern Salt, second Supervisor Batt. Vote unanimous.**

**Supervisor Batt motioned to accept a two- year contract with Zito with a 5% franchise fee, seconded by Supervisor Schmidt. Vote unanimous.**

**Robert Kough presented information on response time from various areas in the Township.**

**Supervisor Sangialosi motioned to remove Yellow Breeches from fire call boxes and use second responder, second by Supervisor Schmidt. Vote unanimous.**

**Supervisor Sangialosi motioned to adopt the Township Handbook Resolution 2025-03 with amendments, second by Supervisor Batt. Vote unanimous.**

**Supervisor Batt motioned to purchase a tamper with the increase in price, second by Supervisor Schmidt. Vote unanimous.**

**Supervisor Sangialosi motioned to advertise the 2026 proposed budgets, second by Supervisor Batt. Vote unanimous.**

**Supervisors discussed options for a new SEO. Secretary Frantz to get more information for the next meeting.**

**Robert Kough gave an update on the new P25 radios. They are to be on line in February.**

**Resident Becky Moorehead read a portion of the Constitution.**

**Supervisor Sangialosi motioned to adjourn the meeting, second by Supervisor Batt. The meeting adjourned at 8:40 PM.**
