Supervisor Sangialosi called the meeting to order and led the group in the pledge to the Flag.

Supervisor Sangialosi appointed Supervisor Batt as the Temporary Chairman, second by Supervisor Schmidt.

Supervisor Sangialosi appointed Janet E. Frantz as Temporary Secretary-Treasurer, second by Supervisor Batt.

Supervisor Batt motioned to appoint Supervisor Sangialosi as Chairman, second by Supervisor Schmidt. Vote unanimous.

Supervisor Sangialosi motioned to approve the minutes of the December 2, 2025 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of December 31, 2025, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for January 5, 2026, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the December 2, 2025 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to apply for dirt and gravel funds for Leeper Farm and Quarry Road projects, second Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to purchase a camera and microphone for the computer to assist with zoom meetings, second Supervisor Batt. Vote unanimous.

There was no COG meeting in December.

Supervisor Schmidt motioned to adopt the Hazard Mitigation plan, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to not retain Vince Elbel for alternate SEO, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to participate in the COG bidding for materials, second Supervisor Batt. Vote unanimous.

The cabin owner that has a fire pit on their deck had not responded in the 30 days for a hearing with the Supervisors. They will need to remove the pit by Memorial Day, 2026.

Robert Kough, Jr. reported that the P25 radios will be active February 17th.

The meeting was adjourned at 8:05pm for an executive session and reconvened at 8:11pm. No decisions were made.

Supervisor Sangialosi motioned to advertise for an assistant Secretary/Treasurer with becoming permanent Secretary/Treasurer, second Supervisor Batt. Vote unanimous.
