

REGULAR MEETING
April 2, 2024

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Strayer, Batt and Sangialosi, Solicitor Marcus McKnight, Planning Committee Chairman, Andre Weltman, Emergency coordinator Robert Kough Jr., residents, Jeff and Margie Schmidt, Becky Moorhead, cabin owner, Phil Rissler, Aaron Miller from Douglas M. Miller Construction Co. LLC and Secretary Frantz.

Bids were opened for the pole building. Only one was received from Douglas M. Miller construction. Douglas M. Miller Construction was awarded the bid for option #1 with snow stops at \$1000.00 extra.

Supervisor Batt motioned to accept option #1 with snow stops, seconded by Supervisor Strayer. Vote unanimous.

Supervisor Sangialosi motioned to approve the minutes of the March 5, 2024 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of March 31, 2024, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for April 2, 2024, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the March 5, 2024 meeting, second by Supervisor Batt. Vote unanimous.

Road crew hauled stone and dragged Leper Farm, Peach Orchard, Ridge and Icehouse roads. Filled potholes on Old Shippensburg Road. Patched Bendersville and Old Railroad Bed roads. Blew leaves from ditches on Icehouse, Cold Springs, Murphy and Old Shippensburg roads. Cut brush on Cold Springs and Icehouse. Took down a tree on Michaux Rd. and High Mountain Road. Had maintenance done on the F550 and the pickup truck.

Secretary Frantz reported that the security alarm was activated and the state police responded. Nothing found.

Planning committee chairman, Andre Weltman went to a meeting with Sarah Fuhrmeister, GIS coordinator. Also discussed the address changes off of Old Shippensburg Rd. for the next gen 911 service.

As part of the Cumberland County Small Bridge program, Toms Run Bridge report done by HRG, engineer for Cumberland County, states weight limit of 19 tons except combinations 35 tons should be posted on Michaux Road. Secretary Frantz will order signs.

Supervisor Sangialosi gave update from the WCCOG meeting. Talk of FDR continues.

Supervisor Batt motioned to adopt Ordinance 2024-01 increasing the compensation of township supervisors according the Second-Class Township code, second by Supervisor Strayer. Vote unanimous.

Solicitor McKnight will reach out to Zito concerning a 2-year contract.

Supervisor Sangialosi motioned to accept the road material bid for Pennsy Supply being that they are the closest, second by Supervisor Batt. Vote unanimous.

Supervisor Batt motioned for Solicitor McKnight to draw up a demolition agreement of a prior house after a new house is completed, second by Supervisor Strayer. Vote unanimous.

Supervisor Sangialosi motioned to approve Resolution 2024-02 concerning Emergency Operations Plan, second by Supervisor Batt. Vote unanimous.

Robert Kough Jr. reported on the Gravel Grinder bike race. No emergency action plan and traffic control received yet.

Supervisor Sangialosi motioned to adjourn the meeting, second by Supervisor Batt. The meeting adjourned at 9:20 P.M.
