Supervisor Sangialosi motioned to approve the minutes of the December 6, 2022 meeting, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of December 31, 2022, second by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for January 3, 2023, second by Supervisor Strayer. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the December 6, 2022 meeting, second by Supervisor Batt. Vote unanimous.

Took 2A's to Ridge, Peach Orchard, High Mountain and Leeper Farm. Plowed snow and applied salt and anti-skid. Purchased battery for tractor.
