

**REGULAR MEETING
December 7, 2021**

The regular monthly meeting of the Cooke Township Supervisors was held at the Township Building, 1700 Centerville Road, Newville, PA. Present at the meeting were Supervisors' Sangialosi, Batt, and Strayer, Planning Committee Chairman, Andre Weltman, Solicitor McKnight, Becky Moorhead and Dan Davis, residents, and Secretary Frantz.

Supervisor Sangialosi motioned to approve the minutes of the November 1, 2021 meeting, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the Treasurer's report as of November 30, 2021, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the checks list for December 7, 2021, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to approve the ratification of checks written after the November 1, 2021 meeting, seconded by Supervisor Batt. Vote unanimous.

Road crew checked roads. Dragged Leeper Farm, Ice house, Cold Springs, Ridge, Peach Orchard, Iron Run, Quarry, Murphy and Old Shippensburg roads. Took 18-ton 2A's to Peach Orchard. Met Lori Glace concerning Leeper Farm drainage. Worked at Penn 2 days. Picked up F450 from D & J. Cut shoulders on Bendersville Road. Patched holes on Pine Tree and Pinebrook. Got trucks ready for snow plowing. Cleaned inlets and outlets on Bunkerhill. Took 2-ton 2A's to Oak Drive where new blacktop was put down. Blew leaves on Pine Tree, Pinebrook, Murphy, Murphy Ext., Quarry, Leeper Farm, Icehouse, Cold Springs, Old Railroad Bed, Iron Run, Ridge, Peach Orchard, High Mountain, and Michaux Oaks.

Supervisor Sangialosi reported on the COG meeting. Dues will remain at half, the budget was approved, and officers elected for 2022.

Supervisor Batt motioned to withdraw the complaint with the District Justice concerning 4 Pinebrook, seconded by Supervisor Sangialosi. Vote unanimous.

Supervisor Sangialosi motioned to approve Resolution 2021-09 setting the 2022 budget and tax rates, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to sign septic agreement for 109 Pine Tree Drive, seconded by Supervisor Strayer. Vote unanimous.

Supervisor Batt motioned to purchase a hidden driveway sign to be posted on State Route 233 near the driveway of the Ironmaster's mansion, seconded by Supervisor Strayer. Vote unanimous.

Supervisor Sangialosi motioned to budget ARP funds for a conference phone, electronic records, ADA parking lot improvements and railing, and employee premium pay, seconded by Supervisor Batt. Vote unanimous.

Supervisor Sangialosi motioned to adjourn the meeting, seconded by Supervisor Batt. The meeting adjourned at 7:50 P.M.
